AKTA FUNGSI-FUNGSI MENTERI 1969

PERINTAH MENTERI-MENTERI KERAJAAN PERSEKUTUAN (PINDAAN) (NO. 2) 2025

PADA menjalankan kuasa yang diberikan oleh seksyen 2 Akta Fungsi-Fungsi Menteri 1969 [*Akta 2*], Yang di-Pertuan Agong membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Menteri-Menteri Kerajaan Persekutuan (Pindaan) (No. 2) 2025**.

(2) Subperenggan 2(*a*) dan (*c*) mula berkuat kuasa pada tarikh Perintah ini disiarkan dalam *Warta*.

(3) Subperenggan 2(*b*) disifatkan telah mula berkuat kuasa pada 1 Januari 2025.

Pindaan Jadual

2. Perintah Menteri-Menteri Kerajaan Persekutuan 2023 [*P.U. (A) 27/2023*] dipinda dalam Jadual—

(*a*) berkenaan dengan Jabatan Perdana Menteri, dengan memotong butiran “Akta Aktiviti Kerajaan Elektronik 2007 [*Akta 680*]” dalam ruang “Jabatan/Perkara”;

(*b*) berkenaan dengan Kementerian Dalam Negeri—

(i) dengan memasukkan selepas butiran “Agensi Penguatkuasaan Maritim Malaysia (APMM)” dalam ruang “Jabatan/Perkara” butiran “Agensi Kawalan dan Perlindungan Sempadan Malaysia (AKPS)”; dan

- (ii) dengan memasukkan selepas butiran “Akta Suruhanjaya Bebas Tatakelakuan Polis 2022 [*Akta 839*]” dalam ruang “Jabatan/Perkara” butiran “Akta Agensi Kawalan dan Perlindungan Sempadan Malaysia 2024 [*Akta 860*]”; dan
- (c) berkenaan dengan Kementerian Digital, dengan memasukkan selepas butiran “Akta Tandatangan Digital 1997 [*Akta 562*]” dalam ruang “Jabatan/Perkara” butiran “Akta Aktiviti Kerajaan Elektronik 2007 [*Akta 680*]”.

MINISTERIAL FUNCTIONS ACT 1969

MINISTERS OF THE FEDERAL GOVERNMENT (AMENDMENT) (NO. 2) ORDER 2025

IN exercise of the powers conferred by section 2 of the Ministerial Functions Act 1969 [*Act 2*], the Yang di-Pertuan Agong makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Ministers of the Federal Government (Amendment) (No. 2) Order 2025**.

(2) Subparagraphs 2(*a*) and (*c*) come into operation on the date this Order is published in the *Gazette*.

(3) Subparagraph 2(*b*) is deemed to have come into operation on 1 January 2025.

Amendment of Schedule

2. The Ministers of the Federal Government Order 2023 [*P.U. (A) 27/2023*] is amended in the Schedule—

(*a*) in respect of the Prime Minister's Department, by deleting the item "Electronic Government Activities Act 2007 [*Act 680*]" in the "Department/Subject" column;

(*b*) in respect of the Ministry of Home Affairs—

(i) by inserting after the item "Malaysian Maritime Enforcement Agency (MMEA)" in the "Department/Subject" column the item "Malaysia Border Control and Protection Agency"; and

- (ii) by inserting after the item “Independent Police Conduct Commission Act 2022 [*Act 839*]” in the “Department/Subject” column the item “Malaysia Border Control and Protection Agency Act 2024 [*Act 860*]”; and
- (c) in respect of the Ministry of Digital, by inserting after the item “Digital Signature Act 1997 [*Act 562*]” in the “Department/Subject” column the item “Electronic Government Activities Act 2007 [*Act 680*]”.
